Based on the Telecom Law no. 41/2009/QH12 dated on Nov 23rd, 2009;

Based on the Decree no. 25/2011/NĐ-CP dated on Apr 06th, 2011 of the Government stipulating in details and instructing to execute some articles of the adjusted, supplemented Telecom Law as per the Decree no. 81/2016/NĐ-CP dated on Jul 01st, 2016 of the Government;

Based on the Decree no. 17/2017/NĐ-CP dated on Feb 17th, 2017 of the Government stipulating the function, duty, right and organization structure of the Ministry of Information and Communication;

Considering the Application attached with the Documents for issuing the license of testing telecom network and service no. 247/SDTV-KD dated on Jan 05th, 2017 and the supplemented documents as per the official letter no. 265 A/SDTV-KD dated on Feb 22nd, 2017 of the Southern Digital Television Co., Ltd.;

As per the proposal of the Head of the Division of License Issuance and Marketing;

PERMITS

Article 1. The Corporate:

Transaction name: **SOUTHERN DIGITAL TELEVISION COMPANY LIMITED.**

International transaction name: SOUTHERN DIGITAL TELEVISION COMPANY LIMITED.

Abbreviated name: SDTV CO., LTD.

Main office address: 09, Le Ngo Cat, ward 07, dist. 3, Ho Chi Minh city, Vietnam.

Business registration certificate of over two-member limited company, business code: 0312964680, the first registration on Oct 10th, 2014 and the third changing registration on May 26th, 2016, issued by the Department of Planning and Investment of Ho Chi Minh city, be allowed to test the telecom network and service as per following stipulations:

- 1. Purpose:** The Corporate is allowed to establish the telecom network for testing, evaluating the technology and **commercialized capacity of services using the new**

technology (movable television technology – T-DMB) but not involving the permission of supplying the testing telecom service, telecom using service.

For supplying the testing telecom using service on the telecom network established from this License, the Corporate must abide by the stipulations of the corresponded specific profession law.

2. **Network kind:** Terrestrial movable telecom network using T-DMB technology.
3. **Service kind:** Being allowed to supply the testing movable television service using T-DMB technology as per the instruction of the Department of Radio, Television and Electronic Information.
4. **Testing scope:** On the area of provinces, cities belonging to the Central Government involving: Hanoi, Da Nang, Ho Chi Minh city and Can Tho.
5. **Service using target customers:** For the testing service users in Vietnam on the testing area.
6. **Connection:** Being connected with the public telecom networks and corporations supplying the Internet service for serving the service testing.
7. **Wireless frequency:** Being allowed to use the wireless frequency channel as per the instruction of the Department of Wireless Frequency.
8. **Quality standard:** Carrying out the stipulations of telecom quality, standard management.
9. **Rate:** Carrying out the stipulations about the service rate management, not collecting the rate of tested service users.

Article 2. The Southern Digital Television Company Limited is responsible:

1. To return the testing frequency after the Testing License being terminated the effect and not being renewed or reissued.
2. To endure itself about the investment effectiveness for the testing.
3. To ensure the rights for the testing service users in case after expiring the testing network and service period but not to be granted the official license or renewed the testing license
4. To fully, punctually report the testing results to the Department of Telecom as stipulated.
5. To safely protect its telecom network and ensure the information security, carry out the stipulations and accept the control of the competent Authorities in ensuring the safety of the telecom network and information security.

6. To carry out the compliances mobilized by the Government in emergency cases and other public interest compliances.
7. To carry out the international cooperation in telecom field as stipulated by the Law.
8. To fully, punctually pay all kinds of fee, cost as stipulated by the Law.
9. To carry out other rights and duties as stipulated by the Law.

Article 3. This License comes into effect since the date of signing.
